



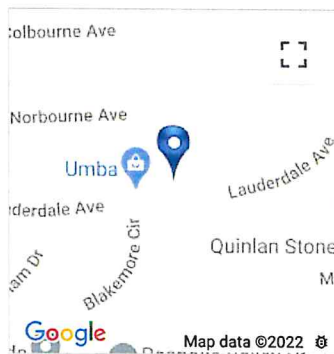

Dear Property Owner(s):

On May 9, 2022, the Planning and Zoning office received a complaint about drainage/runoff from your property that may have caused potential damage to the basement of an adjoining property. Two site visits were conducted on May 10, 2022 and May 16, 2022. During the site visit, an observation was made of the gutter and downspout that was mentioned by the complainant. The downspout was observed to be facing towards the adjacent property with the reported property damage.

This letter is to serve as a courtesy notice regarding this submitted complaint and to recommend the possible remedy to this issue by redirecting the drainage pipe to minimize runoff and flooding on the adjoining property. Please see attached pictures of the site and a copy of the Virginia Surface Water Law.
